

A Medical Technologist also known in the USA as Medical Laboratory Scientist is the equivalent in Latin America to a Bioanalyst, Medical Technologist, Clinical Laboratory Scientist and Microbiologist, who is in charge of laboratory analysis in different areas such as: Hematology, Clinical Chemistry, Microbiology, Urinalysis, Blood Bank, Immunology, Serology, among other analyses..

PROGRAM GOALS

This course provides a contextual and transitional approach to prepare medical technologists graduated abroad to pass the examination of the different professional associations to obtain an international certification recognized in the United States and other developed countries of the world.

Dental Hygenist

PROGRAM GOALS

The purpose of this course is to provide guidance for the preparation and review for the National Board Dental Hygienist Examination (NBDHE) in order to qualify for a license as a Registered Dental Hygienist (RDH) in the state of Florida. A dental hygienist is defined as an oral health professional responsible for treating and preventing periodontal diseases. They do much of their work independently under the supervision of a dentist. They are an important part of dentist-led teams, as it relieves dentists of a considerable workload, leaving only advanced procedures to be performed by the dentist.

JOB RESPONSIBILITIES AND DUTIES OF DENTAL HYGIENISTS

As a state-licensed dental health professional, you may have different responsibilities and duties according to the American Dental Association (ADA), including:

- Dental scaling or cleaning. Scaling and root planing. Administration of intraoral antibiotics.
- Application of preventive materials to the teeth (fluorides and sealants).
- Educate patients on oral hygiene strategies and good nutrition.
- Patient examinations, including oral health assessments, oral health history review, oral cancer screening, head and neck inspections and vital signs monitoring.
- Document preparation and dispatch management
- Removal of dental calculus and plaque from teeth.
- Taking and processing of dental x-rays.
- In addition to the job functions listed above, state requirements may allow these dental professionals to perform duties under the direct supervision of a licensed dentist.

These licensed dental professionals may also perform the following procedures under the direct supervision of a dentist:

- administration of local anesthesia (prior approval of additional course).
- Administration of nitrous oxide (prior approval of additional course).
- Placement and removal of periodontal dressings.
- Suture placement and removal.
- Soft tissue curettage

Students must pass both the National Board of Dental Hygiene Examination (NBDHE) (Step 1) and the state exams (Step 2). All this information will be walked through step-by-step in our administrative mentoring program.

Our Step 1 is designed and focused on providing you with all the information necessary to evaluate your credentials and prepare you to take the NBDHE. Our Step 2 is based on a preparation and review course for the three relevant exams to be taken in the State of Florida in order to qualify for the Registered Dental Hygienist "RDH" license.

Certified Dental Assistant

This course is meant for Dentists or Dental Hygienists graduated abroad who wish to obtain academic their certification as Dental Assistants. Knowing the great demand for high-level professionals such as dentists who wish to work in this field of healthcare in the USA, we designed this course that allows students to prepare to obtain their certifications:

- Dental Assistant
- Expanded Functions
- X-ravs

A dental assistant is defined as an oral health technical professional who works under the direct supervision of a dentist, performing a variety of both clinical and administrative tasks that facilitate the dentist's procedures and ensure the successful operation of the office.

Only Dental Assistants with Expanded Functions can assist dentists during procedures in the patient's mouth. The procedures that dental assistants can perform on patients may vary by state. Only Certified Dental Assistants may take radiographs and must obtain certification from an academic program recognized by the Education Commission. They can also perform prophylactic functions such as: dental sealants, fluoride application, among others.

Dental assistants may also sterilize instruments and perform laboratory tasks, such as processing radiographs or taking dental impressions of patients. In addition to helping dentists prepare for and perform dental procedures. Dental assistants also handle office tasks such as scheduling, billing and record keeping, with a total of 70 tasks for which they are trained as required by law.

Dental Assistant review and preparation for foreign Dentists or Hygienists focuses on Expanded Functions approved by the Joint Comission of Dentistry and Dental Radiography.

Participants who successfully complete the programs and "on-the-job training" requirements will receive their Diplomas and will be eligible for certificates and licenses from the Department of Health.

Florida Health Institute is approved by the Florida Board of Dentistry so that you can obtain these certifications




